



# Assembly of Turkish American Associations

ATAA was co-founded by the American Turkish Association of Washington and the Maryland American Turkish Association in an effort to create a national organization representing the Turkish American community. The first meeting of the ATAA General Assembly was held in May of 1980 in Washington. Delegates from 26 organizations participated and created a coordination committee to write the constitution and bylaws. The bylaws of ATAA were ratified on November 16, 1980 and the first board of ATAA was elected.

From this nucleus, the Assembly has grown into an organization that represents 60 Turkish American organizations in the United States, Canada and Turkey. Today, the Assembly is an influential and fast growing civic organization that pursues the interests of Turkish Americans and friends of Turkey in Washington and beyond, as well as contributes to the strengthening of relations between the United States and Turkey.

A growing base of individual ATAA members support the work of the Assembly through dues and donations. Financial assistance to the operations of ATAA is also granted from the ATAA Endowment Fund, established to secure the long-term growth of the organization.

To fulfill its mission and objectives, ATAA undertakes a number of activities, such as educational seminars for Turkish American communities on grassroots advocacy and civic leadership; conferences on contemporary political, social and economic issues related to Turkey and US-Turkish relations; and cultural events to promote Turkey's rich traditions, art and heritage. Working as an information clearinghouse, ATAA regularly publishes reference material on issues that concern the Turkish American community. The Assembly is also the publisher of a quarterly magazine, The Turkish American. ATAA hosts one of the most dynamic websites on Turkey and maintains and extensive e-mail communication network. Nurten Ural is currently the Assembly of Turkish American Associations' President Elect and an Honorary Consul of the Republic of Turkey for Michigan. She has a Bachelor of Science Degree in Human Environment and Design and a Master of Fine Arts Degree in Interior Design and Human Shelter for the Special Needy-both from Michigan State University. Nurten is the owner of Ural Interiors, Inc., an interior design firm in Farmington Hills, MI. She has received many awards for her business accomplishments and community service work including receiving the 1998 Athena Award, Business Accomplishment Award, Republican of the Year Award, and served on the Board of Directors of two Chamber of Commerces, serving as Vice Chair and Chair on one of them. She has also served on the Board of Directors of the National Association of Women Business Owners, Historic Homes, the Republican Club, and on the Board of the Farmington Area Homeowners Association. Nurten served as Treasurer and as President of the Turkish American Cultural Association of Michigan, as well as ATAA Vice-President of the Midcentral Region.

### Ms. Oya Bain Secretary General (National)

Oya Gain is a graduate of Robert College, who came to the United States as a Fulbright scholar to do post graduate work in Biochemistry. In her professional career, she worked as a Clinical Chemist and Laboratory Director in the Clinical Pathology laboratories of several medical centers in Canada and the US. In 1998, she retired from her position as the Laboratory Director from Georgetown University Medical Center. Oya Bain has been involved in the Turkish -American community issues since 1970s, as the board member of American Turkish Association of Washington DC (ATA-DC), she held positions-as the chair of ATA-DC Membership, Lecture and Turkish Radio committees. She was also a board member and secretary of ATAA in the 1990s and chaired the 1992 ATAA Turkish Heritage month activities. She is the editor of ATANews, a monthly publication of ATA-DC and frequent contributor to the Turkish American magazine. In addition to ATA-DC, she serves on the boards of the Ataturk Society of America (ASA), Washington Turkish Women's Association (WTWA), and Maryland American Turkish Association (MATA) and serves as a liaison among various local associations and ATAA. Oya Bain lives in Bethesda, with her husband Ralph Bain, a chemist and educator, retired from the National Institutes of Health, They have one daughter, Tuvana, a physician in New York.

### Mr. Timur Edip Treasurer (National)

Timur Edib is a third generation Turkish-American, born and raised in New York, and has been active in the Turkish-American community since 1989. He served as President of TAA-Arizona, as Co-Founder and Chair of TAA-Central Pennsylvania, on the Executive Board of TAFSUS, on the Executive Board of ATA-DC, and he currently serves on the Executive Board of MATA. He was also a founding member of the DC chapter of the Turkish American Business Forum. Timur is a Maryland attorney serving the metro Washington, DC area with a solo practice in business and immigration law. Timur also has a Masters in Public Administration, where he concentrated in Public Policy, and has over five years experi-

ence working as a legislative analyst for the Pennsylvania General Assembly's Budget and Finance Committee. Timur and his wife, Melek (Demircan of Ankara), reside in Rockville, Maryland and have two children.

### Mr. Ercument Kilic Past President

Mr. Kilic was born in 1958 in Ankara. He is a graduate of UT-Austin with a BS in Economics and International Politics. He has served numerous times as President of TURANT and as VP of ATAA. Among his accomplishments is his involvement and arrangement of Congressman Jim Moody's trip as the first US Congressman in history to visit Azerbaijan. Due to his formal training in performing arts, he has been a cultural ambassador for Turkey since 1977. He has been invited by various organizations to do seminars and workshops on Turkish folklore in all 50 states in the US and in England, Germany, Holland, Switzerland, the Republic of China, Hong Kong, and Japan. He is currently involved in his own business, TCI Travel and TCI Construction.

### Mr. Gunay Evinch VP Capital Region

Günay Evinch (Övünç) was born in Chicago in 1963 and raised in San Francisco. Gunay has been an ATAA volunteer since 1989, served as ATAA Secretary 1998-2000, and is the current ATAA Vice President for the Capital Region. Between 1991-93, Gunay researched the Ottoman Armenian tragedy at the Ankara University Human Rights Center, with grants from the U.S.

Fulbright Commission and Sasakawa Peace Foundation. Günay received his Juris Doctor from Washington & Lee University (W&L) School of Law, Virginia (1991), completed an EU Legal Studies Program at the University of Madrid (1989), and double majored in Economics and Political Science-Public Service at the University of California, Davis (UCD) (1986). He interned with the San Francisco District Attorney, Sacramento Federal Public Defender, and San

Mateo office of Congressman Tom Lantos. Günay served as President of his law school, President of the American International Law Society W&L Chapter, and Chairman of the Student Programs Board of his college. At UCD, he served as advisor to international and upper-division students, for which he received the UC Regents Outstanding Senior Award.

A former striker for the California U-14 and U-16 teams, Gunay continued his interest in sports, writing the "Sports News" in the ATAA Turkish Times (1993-1998) and founding the Turkish American local soccer teams network, www.AnatoliaFC.com. He practices international law at Saltzman & Evinch, www.Turklaw.Net, and founded www.TurkishLawProject.org and www.EthnicTerror.org. Günay and his wife, Senem, have a baby daughter, Lara, and two golden retrievers, Plato and Luna.

### Mr. Mehmet Celebi **VP Midwestern Region**

Mehmet was born in Aleppo, Syria to a Turkish mother and a Syrian father of Turkish origin. He moved to the United States in 1988.

He received a Bachelor's degree in International Relations and International Economics with concentration in the politics of the Middle East and Central Asia from the University of Wisconsin-Madison. During his studies, he interned at the Milwaukee County District Attorney's Office, The United Nations and various Congressional offices.

Professionally, Mehmet worked as Manager of Financial Services at Prudential Financial until 2004, and was a Partner at New York Life & Securities until recently. In 2005, he started BMH Worldwide along with 2 friends to provide comprehensive business services to the entertainment and television industries as well the corporate world.

Mehmet has been serving as the President of the Turkish-American Cultural Alliance since 2000 and as the Midwest Vice-President of the Assembly of Turkish-American Associations since 2001.

Mehmet served/continues to serve on the Board of several non-profit organizations including National Association of Insurance and Financial Advisors (member of the Board), Turkish-American Doctors Association of Midwest (Advisory Board) and Association of Turkish-American Scientists, Engineers and Architects (Advisory Board).

Mehmet has also been serving on the Chicago Council on Foreign Relations' "Task Force on Islamic relation in the US" since 2003.

Mehmet is fluent in English, Turkish, Arabic and Spanish. He is married to Stephanie and has two children, Emre, 8 months, and Eren, 3 ½ years.

### Mr. Kivanc Oncu VP New York Region

Kivanc Oncu was born in Izmir in 1978, and graduated from Istanbul Technical University's Civil Engineering Department, where he was involved in the activities of MHK (Mühendislige Hazirlik Klübü). During his studies, Kivanc worked as an engineering intern in Amtrak headquarters in Philadelphia. After being involved in the process of ACELA, high-speed rail system for Amtrak, Kivanc started his master's education in business administration at the State University of West Georgia. He spent two years in Atlanta, GA where he got involved with Turkish community through ATAA. In 2002, he moved to New York as a Structural Engineer for Parsons Brinckerhoff to work on various tunnel and bridge projects in and around the Tri-state area. Kivanç is an active member of ASCE (American Society of Civil Engineers), TMMOB (Türkiye Mimarlar ve Mühendisler Odasi Birligi), ITSS (Intercollegiate Turkish Student Society), and ATAA. He is currently pursuing his second master's degree in Structural Engineering in Rutgers University, New Jersey.

### Dr. Atilla Soran **VP North Central Region**

Dr. Atilla Soran was born in Istanbul in 1965 and graduated from medical school in 1989. He worked at the St. Mary's Hospital in England during his residency, which he completed in 1994. Between 1997 -1999, Atilla did postdoctoral fellowship on breast cancer and intensive care at the University of Pittsburgh. He became an Associate Professor of Surgery in 2000, and Professor of Surgery in 2004, and he is currently employed with the University of Pittsburgh as a Professor of Surgery. Atilla was elected as the Vice President of the Pittsburgh Turkish-American Association (PTAA) in 2002, of which he has been the president since 2003. Atilla is currently the ATAA President for North-central region, which includes the states of Delaware, Pennsylvania, and West Virginia.

### Mrs. Ferhan Gomulu VP Northwestern Region

Ms. Gomulu was born in Istanbul. She holds a BS in Public Administration and Political Science, Middle East Technical University, Ankara; and an MA in Economics, Northeastern University, Boston. She started her professional career as a Career Diplomat at the Ministry of Foreign Affairs, Turkey. She worked in IBM Turkey for seven years as the Special Bids Representative. Currently, she works in the Information Services department at Northeastern University and is also working on her Ph.D. dissertation on Internet Law and Public Policy in the same university.

She came to the U.S. in 1991 and has been actively involved in the issues of the Turkish American community ever since. She has been an Executive Board Member of the Turkish American Cultural Society of New England since 1996, and the Secretary General of this organization for the last eight years. She is a public advocate of the Turkish community in the area and works closely with organizations such as AJC and Mayor's Office of Boston. She has led numerous projects and has organized many educational, cultural and social events to promote Turkey and the Turkish culture. She is the Coordinator of the Boston Turkish Arts and Culture Festival and the Boston Turkish Film Festival. She is among the recipients of the "Women of Distinction Award" by the Daughters of Atatürk (2001). Currently the ATAA Vice President for Northeastern Region, she has been actively involved in ATAA and its projects in the region since 1999.

### Mr. Emin Pamucak **VP Southeastern Region**

Emin Pamucak was born in 1959 in Kutahya, Turkey to immigrant families from Ottoman Turkish towns in Bulgaria and Greece. After receiving his elementary school education in Karadeniz Ereglisi and Ankara, Emin attended middle school and high school in suburban metropolitan Washington, D.C. He holds BS and MS degrees in engineering from Bogazici University and University of Maryland. Employed by IBM since 1984, he has worked at company locations in Minnesota, New York, Connecticut and most recently North Carolina.

A firm believer in "by and for" civic representation, Emin is involved in community service and advocacy with emphasis in diversity relations. He has been an active member of ATA North Carolina since 1996, serving as the President of the Association for the last three years. He has received Association's Distinguished Member and Distinguished Leader Awards. In 2004, ATA North Carolina was recognized as ATAA's Component Association of the Year. Emin is also a founding member and the current president of Bridge to Turkiye Fund, which is a US charitable organization focused on improving the underprivileged segments of Turkish society. Emin is happily married to Ayse and is the father of Ayca, a senior in high school.

### Mr. Ertugrul Turhal VP Western Region

Ertugrul Turhal was born in Eskisehir, Turkey in 1958. He holds MS/BS degrees in Aeronautical Engineering and BA degree on Business Administration. He retired as Colonel from Turkish Air Force after 23 years work in logistics systems in different fields of aircraft manufacturing, repair and overhaul services. He came to the US for the first time in 1984 for graduate program in Dayton Ohio. He has worked at the USAF Material Command and Defense Logistic Agency in 1990s. Since 2002, he has worked at Aero Precision Industries Inc as Vice President, Product Technical Support. He is married Birsen and has one son Cem (20 years old) and one daughter Ece (14 years old). ### Dr. Hakan Kaya **VP Northwestern Region**

Hakan Kaya is the Eastern Washington Representative of TACA Washington. Since he moved to Inland Northwest from North Carolina in 2001, he has promoted the Turkish culture in multiple community activities. His mission is to reach out and support Turks, Turkish Americans and American friends of Turkey who live in isolated communities of Eastern Washington, North Idaho, and Montana. During the last two years, he has been reaching these communities via e-mails, phone calls, and actual site visits. As a part of this mission, he founded the Turkish American Cultural Association of Inland Northwest (TACA-IN), which is the first, and the only Turkish American association in Inland Northwest (Montana, Idaho, and Eastern Washington). Hakan functions as the liaison between TACA-WA and TACA-IN. Dr. Hakan Kaya is an award winning physician who specializes in cancer, blood disorders, and stem cell transplantation. He is a partner at Cancer Care Northwest in Spokane, WA. Dr. Kaya has been on the clinical faculty of the University of Washington Medical School since 2002. He is an active teacher for internal medicine residents and medical students in Spokane hospitals. He is in the process of establishing the first stem cell transplantation program in Inland Northwest.

### Mr. Coskun Bayrak VP Southwestern Region

Dr. Coskun Bayrak is a tenured full professor in the department of Computer Science at the University of Arkansas at Little Rock. He also has been serving on the Faculty of Applied Science since 2000. Although he is specialized in the area of software engineering, component based development, distributed systems, and data mining, His primary research interest currently is in biomedical engineering, modeling and simulation, and cellular automata, and monitoring and control. Dr. Bayrak has published one book chapter, over forty research articles in scientific conferences and journals, given tutorials at major conferences, and served on program committees for numerous international conferences and symposiums. Dr. Bayrak holds a BS from Slippery Rock University, and a MS from Texas Tech University, and Ph.D. from Southern Methodist University in Computer Science. He is the founder and first president of Friends of Turkey in Arkansas (FOTIA).

### Mr. Alp Berker **VP Mid-Central Region**

Alp Berker was born in Hull, Canada in 1966. After living in Canada, the U.S.A and Turkey his family settled in Indiana in 1983. He attended Purdue University and received a degree in computer Technology in 1991 and a Masters in Sociology in 1998 from the University of Indianapolis. He currently works as a Database Administrator in Indianapolis. He has served in ATA-IN (American Turkish Association of Indiana) in various capacities, Treasurer in 2003 and has been the Vice-President since 2004. He is married with 3 children.

### Dr. Tamer Açikalin, Chairman

Dr. Acikalin was born in Antalya, Turkey and is a graduate of Ankara University Medical School. He came to the United States in 1973. In 1979, he established the Turkish-American Association of Louisiana (TAAL), and served as the founding president from 1979-1980, and again in 1982-1983. He was also director of TAAL from 1980-1985. Tamer served as the Regional Vice President of ATAA for the South/Southwest region during 1986-1994. In this capacity, he traveled throughout the region in support of the activities of the local organizations. ### What Has Been Accomplished

Responding to inaccurate representations of Turkey. ATAA worked with the Anti-Defamation League (ADL) to remedy slanderous depictions of Turkey and Turkish citizens on programs aired on NBC and FOX Television stations. FOX sent a response and an apology, while NBC required follow-up to elicit a response. ATAA is currently attempting to form an internal committee to monitor and combat such disparaging and erroneous portrayals.

The Congressional Internship Program. The ATAA is successfully continuing its Congressional Internship Program. This summer, we were able to secure 3 times more internships than last year.

ATAA Headquarters Interns. This summer, ATAA was fortunate to have three intelligent, hard-working and dedicated interns helping out in the office. Ayse Tuker, Serkan Ozdemir and Aylin Kumcu were an amazing support system to the office staff during the busy summer months. The three interns fulfilled a wide variety of responsibilities including administrative tasks, database management, and research oriented duties. Each intern was a true delight to have in the office and their hard work certainly did not go unnoticed. At the end of the summer, ATAA hosted a reception for all ATAA-affiliated interns to mingle and meet with each other and ATAA Staff.

The Turkish American Magazine. The content and design of the former Turkish World magazine was revamped and rereleased under the new title: The Turkish American. The Summer and Fall issues of the magazine have been distributed not to only our membership lists but also to the political decision-making institutions in Washington, D.C.

Grassroots campaign. ATAA created an extensive database to match each one of our independent individual members with their Congressional Representatives and Senators. From this database, ATAA staff prepared almost 3000 personalized letters on behalf of the members to educate Congressional Representatives, Senators, and the President of the United States on the position of Turkish Americans on Armenian allegations of genocide.

Capitol Hill Lecture. ATAA coordinated and sponsored a lecture on Capitol Hill by Turkkaya Ataov, Professor Emeritus of Ankara University in Turkey, on the subject of the legacy of the Ottoman Empire. This lecture was a strategic step in educating members of the US Congress from a scholarly perspective on the much debated Ottoman Armenian issue. The lecture was repeated in three other US states: North Carolina, Minnesota and Indiana.

**Annual Delegation Trip.** ATAA members took part in the annual delegation trip in June to Ankara, Istanbul, and Berlin to meet with high-level government officials and NGOs. During the meetings in Turkey, agreements were made with **Bosphorus** University to prepare student camps in Istanbul; with Turkish Press and Media Administration to take American journalists to Turkey; and with the Turkish Historical Society to print more English books on historic subjects. In addition to many other positive engagements throughout the trip, the meetings in Berlin resulted in a cooperation agreement with Euro-Turkish NGOs. The meetings in Berlin raised ATAA's profile in Europe, leading an interview with ATAA Executive Director, Nargiz Abbaszade by German National Television Network on the topic of the upcoming elections in Germany. Such opportunities increase the international visibility of the work of our organization.

Connecting with Euro-Turks and European NGO's. ATAA's president and president-elect made a trip to Germany, Holland and Belgium at their own expenses to begin a new era of cooperation with Euro-Turkish organizations. The response from European side was excellent and many projects as student programs and a cultural event exchange have been initiated. ATAA's last delegation also visited Berlin to connect with Turkish NGO's in this city. Following the trip, Berliner Turks had their first ever demonstration against the Armenian genocide allegations.

Disaster Relief. ATAA started its campaign to help victims of natural disasters by setting up a disaster relief fund for the victims of the Asian Tsunami in January, 2005 that raised over \$11,000. The money will be donated to disaster relief organizations functioning in Sri Lanka and will be used to build a pre-school and/or community center in the south and/or the east of Sri Lanka, with a plaque declaring that the project was a gift of the Turkish-American community and ATAA. In August 2005 another disaster struck much



closer to home. Hurricane Katrina swept across Florida, Alabama, Louisiana, and Mississippi. ATAA and its component organizations responded promptly by initiating donation drives to help Turkish families and all other victims of this disaster. The total relief effort by ATAA and its component organizations totaled over \$10,000. Similar fundraising efforts were initiated for those affected by Hurricane Rita. ATAA Executive Board decided to allocate \$3,000 to be donated to the Red Cross for the relief efforts for these two disasters. Most recently, ATAA started another donation drive to help the victims of the earthquake in Pakistan.

### **OSCE-PA Reception.** During the annual OSCE

(Organization for Security and Cooperation in Europe) Parliamentary Assembly meetings, which were held in July in Washington, DC, ATAA hosted a reception to honor parliamentary delegates attending the reception from the US, Turkey, the Netherlands, Azerbaijan, Kazakhstan, Georgia, Monaco, Macedonia, Sweden, Finland, Moldova and Algeria. Among the delegates that spoke at the luncheon were: Turkish Ambassador to the United States, His Excellency O. Faruk Logoglu; OSCE President Alcee Hastings; OSCE Vice Presidents Nevzat Yalcintas and Nebahat Albayrak; and Turkish-Swedish Parliamentarian Sermin Ozurkut. ATAA organized the event when it learned that the Armenian delegation to the OSCE PA contacted all OSCE PA delegations encouraging their support for the inclusion of a paragraph in the official declaration of the Parliamentary assembly condemning the socalled Armenian Genocide. ATAA immediately activated its membership to write to American delegates of the OSCE PA, urging them to oppose such a paragraph. ATAA President Cengiz also personally contacted OSCE PA President Alcee Hastings to emphasize that the Annual Session of the OSCE was not an appropriate forum to debate Ottoman history. Ultimately, the paragraph was not included. Mobilization of our membership and the meetings with the delegations was crucial to prevent the OSCE PA from accepting such a paragraph in its official declaration.

Peace in the World Project. In May, the "Peace in the World" project was launched in Michigan to cultivate Ataturk's principle of "Peace at Home, Peace in the World." The goal of the project is to promote understanding and acceptance for differences in religions and cultures, as well as worldwide peace. ATAA is planning multi-cultural events such as musical performances from Holland and Turkey, and Modern Art Museum exhibitions from Istanbul under this project. In particular, ATAA plans to bring the "Sufi to Flamenco" music and dance show to the United States. ATAA is accepting applications from component organizations to cooperate in this particular project. Additionally, as part of ATAA's "Peace in the World" Project, a campaign has begun to assist the Ahiska (Meskhetian) Turks adjust culturally, mentally and financially to life in the United States. The Ahiska Turks are an ethnically Turkish group of people who have been displaced twice in the past 60 years. "Peace in the World" has collected funds from generous individuals that will be devoted to purchasing food, welfare enrollment, job searches, transportation to health check-ups, school registration for children, mentoring and much more. So far, the "Peace in the World" Project of Michigan gathered the Meskhetian Turks for a barbeque with other Turkish Americans at the home of ATAA President Elect Nurten Ural. In addition, the Turkish American Cultural Association of Michigan (TACAM) welcomed the Meskhetian Turks at their Zafer Bayrami picnic.

Supporting Turkish-Cypriots in D.C.: ATAA has increased its efforts to stop the isolation of the Northern Cyprus. The summer issue of the Turkish American featured an article covering Northern Cyprus as a fascinating tourist destination. ATAA visited the State Department twice to show our community's support for the Turkish-Cypriots who voted "yes" for the Annan Plan. ATAA stated that the embargo against the Turkish side of the island should be ended and the US should do more to reward the positive attitude by Turkish-Cypriots. ATAA also prepared thank you letters for the members of the Congressional Delegation that visited Northern Cyprus in May of 2005, and ATAA Executive Director Nargiz Abbaszade, with Assistant Director of Media Relations Allison Block, personally delivered the letters to commend them for participating in the delegation. The Fall issue of the Turkish American includes an article by Congressman Whitfield regarding his experiences during the Congressional Delegation visit.



Annual Convention. In cooperation with our Illinois component association, ATAA is organizing the 26<sup>th</sup> annual convention, which will be held November 17-19 in Chicago. The three-day event includes social and political panels as well as the first ever youth component of the convention, organized with the Intercollegiate Turkish Student Association (ITSS). Also a smaller convention in Florida in February 2006 is on the schedule.

Another grassroots campaign. This year, as usual, the Armenian Diaspora has made attempts to pass a resolution in the United States Congress acknowledging its allegations against the Turkish people as truth. Two bills were sponsored for this purpose, H. Res. 316, "Affirmation of the United States Record on the Armenian Genocide," and H.Con.Res 195, the concurrent resolution that were presented for the markup by the House Committee on International Relations Before the markup, ATAA initiated a mailing campaign, sending letters to all ATAA members who live in the districts of members of the International Relations Committee, asking them to send the pre-written letter to their congressman that explain why this legislation is inappropriate, inaccurate and damaging to the US-Turkey relationship. The letter was prepared to be faxed or mailed, including an addressed envelope—all that was required was a stamp and the signature of the ATAA member. Additionally, ATAA President Vural Cengiz wrote a letter to the chair of the committee, Congressman Henry Hyde (R-IL) on behalf of ATAA and its members opposing the hearing on the two bills. ATAA staff met with Congressman Hyde's Legislative Director to express ATAA's opposition to the attempts by the Armenian Diaspora to legislate history. A separate letter by Vural Cengiz was mailed to Speaker of the United States House of Representatives Congressman Dennis Hastert (R-IL) urging him to oppose discussion of the bills on the House floor. ATAA staff also met with some members of the Subcommittee on Africa, Global Human Rights and International Operations to reinforce its case. All members of the International Relations Committee (IRC) also received a letter from President Cengiz urging them to vote against the two resolutions during the IRC mark-up of the bill. Despite the opposition letter submitted by the State Department and ATAA efforts to prevent the resolutions from passing the vote in IRC, the bills passed. ATAA staff and Board of Directors members attended the hearing and briefed ATAA members on all that transpired, urging

them to thank those Congressmen opposing resolutions and to express disappointment with the Congressmen who voted for the resolutions. ATAA President Vural Cengiz sent a letter to the United States Secretary of State Condoleezza Rice thanking her for the State Department's opposition to the two bills. President Cengiz also sent letters expressing his disappointment on behalf of ATAA and its members to those who congressmen who choose to sacrifice United States' interest under pressure from the Armenian lobbying groups.

**Inter-Ethnic Committee.** ATAA Executive Board voted to create a Committee on Inter-Ethnic Relations in order to address ethnic issues related to Turkey in an organized manner, taking a pro-active approach. The first committee meeting was held in October.

Turk Evi Lecture Series. ATAA kicked off a new lecture series held at the ATAA Headquarters. The purpose of the lecture series is to educate Turkish Americans on issues that are of concern to them as a community and to collectively discuss these issues with leading academics. ATAA has hosted the following three lectures: on August 31, 2005 by Professor Nursen Mazici: "Armenian Problem: Genocide Allegations and The Reasons Behind"; on September 15, 2005 by Dr. Faruk Sen: "The Integration of the Turkish Minority in Europe"; and September 21, 2005 by Ambasador Gunduz Aktan: "The Impact of Armenian Resolutions on Sustainable Peace with Turkey." ATAA plans to host such lectures on a wide variety of subjects regularly in the future.

Making Connections. ATAA Executives and staff had meetings with organizations such as the American Turkish Council (ATC), Institute of Turkish Studies, the Global Uzbek Council and others to build strong and valuable relationships with other Turkish-American and Turkic organizations.



**Sufi Nights at ATAA.** The Sufi-Socrates Café is a forum in which members of the community can come together to "expand our knowledge of ourselves and each other and how we relate to the greater world existence." The group has been meeting every third Thursday of the month since February 2005 at the Café founder's home. In October, ATAA hosted the gathering at its headquarters. Attendees discussed the recent start of European Union accession negotiations from the Turkish perspective.

Sponsorship of ATAA component organizations events. ATAA was proud to donate to the 3<sup>rd</sup> Annual ATA-DC Turkish Festival, which was held in October in Washington, DC. Also, ATAA showed its support for the Fourth Boston Turkish Film Festival in April at the Boston Museum of Fine Arts.

#### Meetings with Congressmen and Congressional Staff.

ATAA Executive Director Narguiz Abbaszade and Assistant Director of Media Relations Allison Block visited Congressmen and their staffers on Capitol Hill several times during the past three months. ATAA has also met with several congressional representatives to communicate ATAA's membership's position on issues such as political declarations on the Ottoman Armenian issue. Additionally, ATAA President Vural Cengiz and Anadolu Club president Tayfun Selen attended a breakfast with Rep. Pascarell in New Jersey. Recognizing the significance of positive relationships with members of Congress, ATAA has plans to schedule meetings with Congressmen and their staffers on a more regular basis. The primary purpose of the visits is to introduce ATAA to Congressmen and their staffers and to explain the mission of ATAA. The meetings also serve to inform the ATAA staff how our members can more effectively communicate with their congressional representatives and become politically active Turkish-American citizens. In the near future, ATAA hopes to formally educate their membership on how to organize on the grassroots level and how to have successful communication with members of the US Congress, Senate and Administration.

### PLANS FOR THE FUTURE

Increasing component organization activity. We have created small circles to increase local organizations' activities in 45 states, which will carry out public advocacy work. ATAA's vice-presidents and other community leaders are working closely to achieve better representation of the community and Republic of Turkey on the local level.

First ever Turkish World Youth Assembly. In June 2006, ATAA, with the cooperation of European Turks, is planning to organize the first ever Turkish World Youth Assembly in Brussels.

Working with Turkish children and youth. ATAA is formulating plans to cooperate with the following universities on the following projects for the summer of 2006: a Turkish Youth Camp with Bogazici University; a Turkish Children's Camp with Akdeniz University; and a Turkish-American Political School with Bahcesehir University.

Building a future for our children. The new ATAA administration has been focusing on public advocacy work and projects for our youth. We are aware that we need to do more for our children in order to build a bright future for coming generations. The year 2006 will be the "Year of Children and Youth" with many associated projects.

Along with several additional awards he received for his writings was the Best Book Award, which was presented to him by the Faculty of Communications for his book "Letters to My Daughter."

He was the Founder and Director of School of Social Work, Hacettepe in 1968; Advisor to the Ministry of Tourism from 1976 to 1979; Member of the High Council for Culture in the Ministry of Culture from 1978 to 1979; Advisor to the Ministry of Youth and Sports from 1978 to 1979; Founder and Chairman of the Board, KAMAR, Public Opinion Research Firm from 1987 to 1991; Undersecretary for the Ministry of Culture, 1992-1995; and Professor of Sociology at Yildiz Technical University.

He worked for Hurriyet between 1983 and 1987 as the advisor and administrator. Since 1996, he has been a columnist in Cumhuriyet.

### FARUK LOGOGLU

Ambassador Logoglu arrived in Washington, D.C. on September 23, and formally assumed his duties following the presentation of his credentials to President George W. Bush on October 10, 2001. He previously served as the Turkish Ambassador to Copenhagen, Denmark, from 1993 to 1996, and to Baku, Azerbaijan, from 1996 to 1998. He was the Undersecretary of the Turkish Ministry of Foreign Affairs (MFA) from 2000 to until his current assignment to the U.S. capital.

Ambassador Logoglu joined the MFA in 1971 and has been involved in the major areas of Turkey's external relations. Earlier in his career, he worked on the Middle East and European matters at the MFA, served as First Secretary at the European Union (then EEC) from 1973 to 1976, and in Dhaka, Bangladesh, between 1976 and 1978. During the 1980s, Ambassador Logoglu, as Head of MFA Department, focused mostly on bilateral political affairs, and Cyprus and Greece issues, serving as a Counselor at the Permanent Mission of Turkey to the United Nations in New York from 1980 to 1984, and Consul General in Hamburg, Germany, from 1986 to 1989. He was appointed as Deputy Undersecretary subsequent to his return from Baku in 1998.

Ambassador Logoglu was born in Ankara in 1941. He

attended Brandeis University (Boston) where he majored in Political Science receiving a Bachelor of Arts degree in 1963. Ambassador Logoglu then received his Ph.D. in Political Science from Princeton University in 1969.

Ambassador Logoglu was a lecturer in Political Science at Middlebury College in Middlebury, Vermont, 1969-1970. He is the author of *Ismet Inonu and the Making of Modern* Turkey, a book about the times and life of the second President of the Turkish Republic. He is married to Mevhibe (Mimi) Logoglu.

### **GUNAY EVINCH**

Günay Evinch (Övünç) was born in Chicago in 1963 and raised in San Francisco. Gunay has been an ATAA volunteer since 1989, served as ATAA Secretary 1998-2000, and is the current ATAA Vice President for the Capital Region. Between 1991-93, Gunay researched the Ottoman Armenian tragedy at the Ankara University Human Rights Center, with grants from the U.S.

Fulbright Commission and Sasakawa Peace Foundation. Günay received his Juris Doctor from Washington & Lee University (W&L) School of Law, Virginia (1991), completed an EU Legal Studies Program at the University of Madrid (1989), and double majored in Economics and Political Science-Public Service at the University of California, Davis (UCD) (1986). He interned with the San Francisco District Attorney, Sacramento Federal Public Defender, and San Mateo office of Congressman Tom Lantos. Günay served as President of his law school, President of the American International Law Society W&L Chapter, and Chairman of the Student Programs Board of his college. At UCD, he served as advisor to international and upper-division students, for which he received the UC Regents Outstanding Senior Award.

A former striker for the California U-14 and U-16 teams, Gunay continued his interest in sports, writing the "Sports News" in the ATAA Turkish Times (1993-1998) and founding the Turkish American local soccer teams network, www.AnatoliaFC.com. He practices international law at Saltzman & Evinch, www.Turklaw.Net, and founded www.TurkishLawProject.org and www.EthnicTerror.org. Günay and his wife, Senem, have a baby daughter, Lara, and two golden retrievers, Plato and Luna.

### **HUGH POPE**

Hugh Pope has reported from Turkey, the Middle East and Central Asia for more than two decades. He is currently lives in Turkey, on sabbatical as a staff correspondent of The Wall Street Journal and is preparing a new book on the Middle East. Born in South Africa in 1959, Pope was educated in Britain and received a BA in Oriental Studies (Persian and Arabic) from Oxford University in 1982.

Hugh Pope is the co-author with his first wife Nicole of

Unveiled: A History of Modern Turkey, selected as a New York Times 'notable book' in 2000. His book Sons of the Conquerors: the Rise of the Turkic World, an account of travels among Turkic peoples and communities from China to America, was published in New York, London and Istanbul in 2005. Ambassador James Holmes (Ret.) is the President and Chief Executive Officer of the American-Turkish Council, a bilateral, non-profit organization dedicated to the strengthening of U.S.-Turkish trade, investment and cultural relations, and to the promotion of awareness and understanding of U.S.-Turkish issues.

Ambassador Holmes was elected to the Board of Directors of the American-Turkish Council, and subsequently as President of the ATC, in April 2005. The ATC, complemented by its companion cultural organization the American Friends of Turkey, has approximately 222 corporate and individual Members in Turkey and the United States. It is the foremost organization for the promotion of commerce, cultural awareness and public-private understanding between Turkey and the United States.

Ambassador Holmes is a 37-year veteran of the United States Foreign Service with overseas experience in Latvia, Turkey, Norway, New Zealand and Pakistan. He was Deputy Chief of Mission at the American Embassy in Ankara, Turkey from 1992-1995. Subsequently, he was the President's Coordinator for Assistance to Central and Eastern Europe, Ambassador to Latvia, Special Envoy for the Balkans, founder of the Department of State's Office of eDiplomacy, and the Department's Chief Knowledge Officer and Deputy Chief Information Officer.

Ambassador Holmes was born in Upstate New York. He

was educated at Colgate University, Johns Hopkins University School of Advanced International Studies, and the National Defense University. He is married to Constance Cooper Holmes. They have two married daughters, and to their great delight, three grandsons.

### LEVENT YANIK

Mr. Yanik is the Founder and President of e-Devlet Technologies, a Washington, D.C. based company specializing in e-government and information technology services.

Prior to founding of e-Devlet Technologies, Mr. Yanik worked at the World Bank Group as an information technology consultant, focusing on e-government strategies for developing countries. He also worked as a research fellow at the U.S. Department of Energy's Thomas Jefferson National Accelerator Facility, and the U.S. Department of Commerce's National Institute of Standards and Technology (NIST).

Ketene has been involved in the Turkmen nationalist movement since 1969. He established a Turkmen nationalist organization that was active in all Turkmen areas from Telafer-Mosul in the north in Kerkuk, Tuz and Baghdad. He took part in various activities to promote identity awareness and national revival among the Turkmen youth. Between the years of 1971-1977, he participated in the cultural activities of the Iraqi Turks Culture and Solidarity Association in Istanbul, Turkey. In 1997, he established the Iraqi Turkmen Organization to promote and introduce the Turkmen cause to the western world (U.S., Canada, Australia, and Western Europe).

Orhan Ketene was appointed as the U.S. representative for the Iraqi Turkmen Front (ITF) on October 29, 2001 and opened a representative office for ITF in Washington, D.C. on April 2002.

His professional background includes that of being a Project Engineer at the Turkish Aircraft Industries, participating in the establishment of the Turkish military aircraft industry; working as a Designer, Process Engineer, and Project Engineer at General Motors Diesel Division, Canada.

### **OSMAN "OZ" BENGUR**

Oz Bengur has a wide range of experience that encompasses a thirty-five year career as a successful businessman and entrepreneur, and leadership roles in state government, community affairs and politics.

Mr. Bengur is a candidate for the United States House of Representatives in 2006 from Maryland's 3<sup>rd</sup> Congressional District.

He is investment banker with a firm he co-founded, Bengur Bryan & Co. that raises capital and provides financial and strategic advice to mid-size companies. Previously, he was a senior public finance and corporate investment banker with

Alex. Brown & Sons Incorporated (now Deutsche Banc). Mr. Bengur has been active in the Baltimore, Maryland community where he has served on several not-for-profit boards. He is currently Treasurer of the Maryland Democratic Party and a Trustee of the Baltimore County Public Library.

Before starting his business career, Mr. Bengur was a special assistant to the Governor of Maine and worked in Massachusetts and Illinois state government in the areas of juvenile justice and children and family services.

In 2002, Mr. Bengur was the first Turkish-American to be a candidate for the U.S. Congress. His activities in the Turkish-American community include having served on the board of the Turkish-American Business Forum in New York. In 2002, He received the Turkish-American of the Year Award from the Federation of Turkish-American Associations in New York and the ATAA.

He was born and raised in the Washington DC area where he attended public schools. He is a graduate of Princeton University and holds a graduate degree from Cambridge University, England.

Mr. Bengur is a proud father of three children: Noah, a Captain and jet pilot in the U.S. Marine Corps who is currently deployed in Iraq, Dinah, a senior at Colby College and Nicholas, a sophomore at Towson High School.

#### SCOTT TAYLOR

Scott Taylor, a former professional soldier, has been editor and publisher of Esprit de Corps, an Ottawa-based magazine celebrated for its unflinching scrutiny of the Canadian military, since 1998.

Throughout the mid-1990s, this little independent magazine embarked on a campaign to expose crime and corruption in the upper echelons of the Canadian Forces. After exposing a top-level cover-ups and scandals while defending the rights of the rank and file soldiers, Taylor was dubbed the "Voice of the Grunts" by the Globe and Mail, a "Bone in the Brass Throats" by the Toronto Star, and a "One Man Army" by the Toronto Sun.

In 2001, much to his mother's delight, Taylor was also named one of the Homemaker Magazine's Top 60 Men We Love" in Canada.

During the past 16 years, Taylor has logged over one million air miles as a war correspondent reporting from such global hot spots as the Persian Gulf, Cambodia, Western Sahara, Croatia, Bosnia, and most recently from Iraq, Turkey, Yugoslavia, Kosovo, and Macedonia. Since August 2000,

Taylor has made a total of 20 trips into Iraq to report on the effects of the UN sanctions, the ravages of depleted uranium following the 1991 Gulf War, and the heightening tensions with the U.S.

In March 2003, during his last trip prior to the United States' intervention, Scott Taylor was asked to leave Iraq for fear of his being a spy for the Israeli Mossad. Following the swift U.S. victory, Taylor has returned frequently to Iraq to view first-hand the ongoing humanitarian crisis plaguing this still embattled country.

Scott Taylor regularly appears in the Canadian media as a military analyst, and is the recipient of the 1996 Quill Award for outstanding work in the field of Canadian communications. That same year, he also won the Alexander MacKanzie Award for journalistic excellence.

A weekly columnist for the Halifax Herald and Windsor Star, Taylor is also the columnist for the Osprey newspaper chain and has contributed to the Ottowa Citizen, McLean's, the Globe and Mail, Toronto Sun, Reader's Digest, and Canwest-Global television network.

Taylor is also the author of five bestsellers- Tarnished Brass: Crime and Corruption in the Canadian Military and Tested Mettle: Canada's peacekeepers at War (both with Brian Nolan), Inat: Images of Serbia, the Kosovo Conflict and Diary of an Uncivil War: The Violent Aftermath of the Kosovo Conflict and Spinning on the Axis of Evil: America's War Against Iraq.

Scott Taylor has just released his sixth book dealing with his experiences in northern Iraq called "Among the 'Others': The Forgotten Turkmen of Iraq", which was first published in October 2004 by Esprit de Corps Books.

### STEPHEN KINZER

Stephen Kinzer is a veteran New York Times correspondent who has reported from more than fifty countries on four continents. During the 1980s he covered revolution and social upheaval in Central America. He is coauthor of Bitter Fruit: The Story of the American Coup in Guatemala and author of Blood of Brothers: Life and War in Nicaragua and Crescent and Star: Turkey Between Two Worlds. Kinzer is currently a New York Times correspondent based in Chicago.

### STEVEN A. COOK


