This was another first in ATAA and we had incredible success working with the Institute for Turkish Studies and Turkic organizations under ATAA's umbrella. I hope this will be an annual event to unite all Turkic communities in establishing a higher voice in Washington for all. ATAA has been helping Azeri communities all over the US, from Florida to California, with their new organizations. We would like to unite our community in actively and legitimately pursuing our collective interests on all levels -politically, socially and educationally- with one voice. I truly believe that ATAA has the capacity to be the unifying force behind all groups that share our principles of integrity, dignity and service to society.

I want to express my gratitude for the dedicated work of the Convention Committee, especially co-chair Nurten Ural, and the Central Office staff. Assembly of Turkish American Associations

ATAA was co-founded by the American Turkish Association of Washington and the Maryland American Turkish Association in an effort to create a national organization representing the Turkish American community. The first meeting of the ATAA General Assembly was held in May of 1980 in Washington. Delegates from 26 organizations participated and created a coordination committee to write the constitution and bylaws. The bylaws of ATAA were ratified on November 16, 1980 and the first board of ATAA was elected.

From this nucleus, the Assembly has grown into an organization that represents 60 Turkish American organizations in the United States, Canada and Turkey. Today, the Assembly is an influential and fast growing civic organization that pursues the interests of Turkish Americans and friends of Turkey in Washington and beyond, as well as contributes to the strengthening of relations between the United States and Turkey.

A growing base of individual ATAA members support the work of the Assembly through dues and donations. Financial assistance to the operations of ATAA is also granted from the ATAA Endowment Fund, established to secure the long-term growth of the organization.

To fulfill its mission and objectives, ATAA undertakes a number of activities, such as educational seminars for Turkish American communities on grassroots advocacy and civic leadership; conferences on contemporary political, social and economic issues related to Turkey and US Turkish relations; and cultural events to promote Turkey's rich traditions, art and heritage. Working as an information clearinghouse, ATAA regularly publishes reference material on issues that concern the Turkish American community. The Assembly is also the publisher of a quarterly magazine, The Turkish American. ATAA hosts one of the most dynamic websites on Turkey and maintains and extensive e-mail communication network. a Bachelor of Science Degree in Human Environment and Design and a Master of Fine Arts Degree in Interior Design and Human Shelter for the Special Needy-both from Michigan State University. Ural is the owner of Ural Interiors, Inc., an interior design firm in Farmington Hills, MI. She is also the owner of Ural Properties. She has received many awards for her business accomplishments and community service work including the Athena Award, Business Accomplishment Award, and the Republican of the Year Award. Ural now serves on the Board of Directors for the Detroit Institute of Arts, and served on the Board of Directors of two Chambers of Commerce, serving as Secretary, Vice Chair and Chair on one of them. She has also served on the Board of Directors of the National Association of Women Business Owners, Professional Women's Round Table, Historic Homes, the Republican Club, and on the Board of the Farmington Area Homeowners Association. Ural served as the Treasurer, President, and Trustee of the Turkish American Cultural Association of Michigan, as well as ATAA President-Elect and as Vice-President of the Midcentral Region.

Evinch((Övünç) is second generation Turkish American, born in Chicago in 1963, raised San Francisco, living and working in Washington, DC where ATAA is headquartered. From 2004 to 2006 he served as the Capital Region



Vice-President of ATAA. Special projects and committees he took part during his term in the Assembly include the Renewal Program, Public Outreach Program, and Anti-Defamation Committee. He was the Secretary General of ATAA between 1998 and 2000. From 1992 to 1998, Evinch contributed to ATAA Turkish Times with his writings on the sections of "Eurasia News", "Sports News", and "Star Turk". He received his Juris Doctor Degree from Washington & Lee University, VA (1991);

B.A. Economics and B.A. in Political Science-Public Service from University of California, Davis (1986). He is a receipient of UC Regents Outstanding Senior Award (1986); European Union Legal Studies Program, University of Madrid (1989). Principal of the Saltzman & Evinch, PC, Evinch's field of expertise include corporate law, commercial transactions, international finance, franchises, treaties, anti-terror, litigation (www.Turklaw.Net). U.S. Fulbright Scholar and Japan Sasakawa Scholar on the Armenian allegation of genocide, Evinch did research while in Ankara University from 1991 to 1993. He is also a researcher, on issues related to Aegean Turkey (www.TurkishLawProject.org), and on issues related to Armenian terrorism (www.EthnicTerror. org). His writings were published in Wall Street Journal (Iraq), New York Times (Bosnia), Washington Post (PKK), International Herald Tribune (Turkish Jews), Atlantic Monthly (Turkish German athletes), Christian Science Monitor (twice - Wartime Information Security, Turkish workers in Germany), Barrister (PKK), Turkish Policy Quarterly (Armenian Cause), Ankara University Journal of Human Rights (Turkish Human Rights System), The Turkish American (twice - "The Armenian Cause Today", "Iraq Report - Eyewitness"). Evinch has given speeches at Turkish, American, and European universities on topics of Turkish American Integration and PKK, Turkey and Iraq, Northern Cyprus, Armenian Cause, Turkish Code Law, and more. He served as the president of the Washington and Lee University School of Law and the American International Law Society, Vice President of the College of San Mateo, Counselor of the UC Davis International Relations Students, UC Davis Upper Division Students, and American Turkish Veterans Association (ATVA). Evinch is also the Co-Founder of the Turkish American soccer club (www. AnatoliaFC.com), and Children's Soccer Coach in Lexington, Virginia.

OYA BAIN Secretary General

Oya Bain is a graduate of American College for Girls currently Robert College of Istanbul. She came to the United States as a Fulbright scholar to do post graduate work in Biochemistry. In her profes-



sional career she has worked as a clinical chemist and laboratory director in the Clinical Pathology laboratories of several medical centers in Canada and U.S. In 1999 she retired from her position as the Director of Department of Laboratory Medicine at Georgetown University Hospital. Oya Bain has been involved in the Turkish American

community since 1970. As the board member of American Turkish Association of Washington DC (ATA-DC), she held positions, at various times, as the chair of ATA-DC Membership, Lecture and Turkish Radio committees and ATA News editor. She was the Capitol Region Vice President and Secretary of the Assembly of Turkish American Associations in the 1990s and chaired the 1992 ATAA Turkish Heritage Month activities. She served on the boards of Ataturk Society of America and Maryland American Turkish Association. Currently she is on the boards of ATA-DC and Washington Turkish Women's Association. She is also a member of The Hospitality and Information Service (THIS) in Washington DC, a service organization for the diplomatic community. She received numerous awards from ATA-DC, American Turkish Council and ATAA. In November 2005, she received the ATAA Turkish American of the Year award. Oya Bain lives in Bethesda, MD with her husband Ralph Bain, a chemist and educator, retired from the National Institutes of Health. They have one daughter, Tuvana, a physician in New York. Oya Bain strongly believes that the Turkish Americans need to be better informed and be active in the American political and civic organizations. She promotes programs and projects to educate and empower the Turkish American community in the political areas and grassroots activities.

Hakan Kaya attended high school at Ankara Atatürk Anadolu Lisesi and graduated from Ankara Üniversitesi Tıp Fakültesi (Ankara University, Medical School) in Turkey. He has lived in the United States since 1993. Following



seven years of medical training in different states, he moved to Inland Northwest in 2001. Since then, he has been an active Turkish American community member by promoting Turkish culture in multiple community activities. His mission has been to reach out and support Turks and Turkish Americans who live in isolated communities of Inland Northwest. As a part of this mission, he founded Turkish American Cultural Association of Inland Northwest (TACA-IN), which is the first and the only Turkish American association in Inland Northwest. He also served as the Eastern Washington Representative of TACA-Washington. TACA-Montana, the first Turkish American association in Montana, was founded with his encouragement. In November 2005, ATAA members elected Hakan Kaya to the position of ATAA VP for Northwestern Region, covering Alaska, Idaho, Montana, Oregon, and Washington, Wyoming. He continues to be one of the most active members of the ATAA National Board of Directors. In addition to community

She was quoted in the December 2003 issue of National Geographic in an article on tea. Her articles were published in TEA: A MAGAZINE (Autumn 2004) and the Turkish culinary magazine Yemek ve Kultur (Spring 2006).

OYA BAIN

Oya Bain is a graduate of Robert College, who came to the United States as a Fulbright scholar to do post-graduate work in Biochemistry. In her professional career, she worked as a Clinical Chemist and Laboratory Director in the Clinical Pathology laboratories of several medical centers in Canada and the US. Zeyno Baran is the Director of the Center for Eurasian Policy and a Senior Fellow for the Hudson Institute, Washington, D.C. She was a national chairman of the Assembly's Curriculum Committee History and Social Science. She has represented Turkish American interests at high-level State Department meetings, addressed human relation commissions nationwide, worked on a one-to-one basis with innumerable congressional representatives and their staffs as well as delivered expert testimony before the Committee on Foreign Relation Relations. She was developing and implementing educational and public relations programs as deemed necessary. She has appeared on radio and television nationwide as an educator, advocate and facilitator for a better understanding of Turkey and her people.

MICKEY KATZ-PEK

Mickey Katz-Pek, spent 17 years in academic administration at the University of Michigan in the Departments of Microbiology and Reproductive Endocrinology. Department of History from 1986 to 1992. From 1967 to 1969 he taught at the Middle East Technical University and Ankara University in Turkey. His books include Muslims and Minorities, Death and Exile, The Population of Palestine, The Ottoman Turks, The Ottoman Peoples and the End of Empire, Population History of the Middle East and the Balkans, and Who Are the Turks? (with Carolyn McCarthy). His most recent book is The Armenian Rebellion at Van (with Esat Arslan, Cemalettin Ta**\$**kiran, and Ömer Turan). He has held a Senior Research Fellowship from the Ú.S. National Endowment for the Humanities, a National Needs Postdoctoral Fellowship from the National Science Foundation, a Fulbright-Hays fellowship, an International Research and Studies Program grant from the U.S. Department of Education, and other grants and awards.

AYSE OGE

Ayse Oge is an internationally known business woman, instructor, seminar leader, author, public speaker and consultant. Ms. Oge has worked for CENTO (Central Treaty Organization), an economic and political international organization based in Ankara, Turkey. Ms. Oge taught Exporting at Long Beach City College and served on the Advisory Board, International Trade Program at Woodbury University in 2004. Ambassador Sensoy is a graduate of the Faculty of Political Sciences at the University of Ankara.

A native of Azerbaijan graduated from Baku State University with a MS in Chemistry. Since then, Ms. Shakbazov has worked in public education and private sector organizations. She moved to US in 1997. In Washington, Ambassador Wilson worked for Secretaries of State Baker, Eagleburger and Christopher in 1992-94 as Deputy Executive Secretary of the Department of State. ATAA Capitol Hill Lectures

The Assembly arranged two lectures on Capitol Hill this year. On Wednesday, January 18th, Professor Ilber Ortayli, the Director of the renowned Topkapi Palace Museum and lecturer at Bahcesehir and Galatasaray Universities, spoke about Turkey's transition from the Ottoman Empire to a modern state, covering its political, economic, and administrative transformation. On Thursday, March 23rd, Ambassadors Gunduz Aktan and Omer Lutem addressed and discussed the Armenian Question with a diverse audience consisting of legislative assistants, students, educators, ATAA Members, representatives of local think-tanks, and others.



ATAA Turk Evi Lecture Series

The "Turk Evi Lecture Series", initiated in mid-2005, continued throughout 2006. ATAA hosted a panel discussion at its headquarters on Wednesday, January 18th on the subject of "Turkey in the 21st Century." A delegation of scholars from Bahcesehir University (Prof. Dr. Hasan Koni, Prof. Dr. Ilber Ortayli, Prof. Dr. Nilufer Narli, and Prof. Dr. Suheyl Batum) discussed modern Turkey and the rapid changes that have occurred in the past few years in the political realm, the economic and business world, and the social sphere.



On Friday, May 1st, Azerbaijan's Diaspora Minister, Nazim Ibrahimov, visited the Turk Evi and accompanied a large group of participants from town while speaking of his experiences as a Diaspora Minister.



Nevruz Celebration in Washington, DC For the first time ever in the U.S., the Turkish and Turkic-American communities got together to celebrate Nevruz, a very special holiday symbolizing the awakening of nature in spring and the solidarity that is imbued in people. More than twenty component organizations and over six hundred members and friends gathered in Washington, DC and enjoyed a potpourri of folkloric dance and musical performances from the Turkish and Turkic world, while partaking in a cultural journey through the artistic displays and delicious cuisines of the participating countries. We were honored to have the support of the Embassies of Azerbaijan, Kazakhstan, Kyrgyzstan, Turkey, Turkmenistan, and Uzbekistan. Thanks to the Chair of the Organizing Committee, Cemal Altayli, and the committee members' diligent work, the Nevruz Celebration was a great success.








Support for Meshketian Turks

More Meshketian Turks (Ahiska Turkleri) arrived in the U.S. as refugees from the troublesome conditions they have been facing under the Soviet Regime since Stalin's rule. Local Turkish American communities and organizations across the U.S. were informed about the situation of the arriving Meshketian Turks and encouraged to extend a helping hand. Community members in Georgia, Florida, Michigan, and Washington were able to locate and visit some of the Meshketian families and provide moral and financial support during their adaptation period to their new environment.



In September, the School of Politics, a two-week long program, organized by the Assembly and the Bahcesehir University of Istanbul, took place in Washington, DC. The participants of the program -college graduates and students, professors, businessmen, and city officials-came from Turkey to stay in the capitol city for a few weeks and attend lectures and panels in government offices and local Think Tanks, NGOs, and firms to gain more insight and understanding of American politics and as current issues. As a result of the program, the Assembly not only gained the trust of twelve of our countrymen, but also received \$8.450.63 as revenue.

Anti-defamation Efforts

In the early months of the year, the Assembly started the "Armenian Revolt and Deportation" petition to PBS for a balanced portrayal of the story on Armenian genocide allegations. Over 40,000 signatures were collected, and letters on Turkish-Americans' concerns about the issue were sent to Mr. Atlas, Mr. Getler, and Mr. Kerger. Though the "Armenian Revolt" movie was not aired, the "Desperate Hours" documentary was, for the first time, broadcast, on 75 PBS stations.

On May 16th, the article "Turkey, Armenia and Denial" was published in the Editorials section of the New York Times. In response, ATAA President sent a message to the New York Times, expressing the disappointment that the statements made in the article would cause among Turks and the Turkish-American community, not only because "it portrayed a poor understanding of some of the basic historical facts concerning the tragic conflict between the Turks and Armenians, but also because its errors, both of commission and omission, tend[ed] to perpetuate the usual false stereotypes about Turks."

On October 16th, 2006, the President of ATAA sent a letter to the mayor of Las Vegas, protesting the city's





decision to erect an "Armenian Genocide Memorial" in Centennial Plaza and asking that it be abandoned. The French Ambassador to the U.S. also received a message from ATAA, as a response to the intention of the lower house of the French Parliament to pass a bill that would "make it a crime to disagree with, oppose, debate, or question the Armenian allegation of genocide." Also mentioned in this letter was the Assembly's involvement in the Griswold v. Massachusetts case, a case in which several non-Turkish American students, parents and teachers are working to protect freedom of speech by asking that scholarly materials that question the Armenian allegation of genocide be reinstated into the teachers' curriculum guide.

In addition to serving as a watchdog and fighting against the imbalanced presentation of controversial issues regarding Turkey and the people of Turkey, the Assembly also acknowledged and accredited those who supported a more objective and reflective approach to conflict resolution. ATAA President Vural Cengiz sent a letter of support to the prominent French historians who have issued an open declaration calling for the repeal of laws that legislate historical events.

Public Advocacy Efforts

In view of the increased media and ethnic lobby attacks against Turkish Americans and Turks on various issues, especially regarding the Armenian allegation of genocide, ATAA has established the Public Outreach Committee (POC). The purpose of the POC is the promotion of a balanced understanding of Turkey among the American public, political, educational and media organizations, and the coordination with local Turkish-American organizations of efforts necessary to create such a balance.

In April, a copy of Professor Guenter Lewy's most recent book, The Armenian Massacres in Ottoman Turkey: A Disputed Genocide" was sent to each House Representative and Senator. Meanwhile, Prof. Lewy was in town and had two book-signing events, one in the Library of Congress and the other in Congregation Beth El in Bethesda to discuss the issues addressed in his work.

In August, ATAA's Central Office sent out a copy of the "Armenian Revolt" movie to the presidents of ATAA Component Associations. The presidents were asked to provide the means for their community members and friends to attend a screening of this significant documentary.

During mid-summer and fall, ATAA's President visited North Carolina, New Jersey, Georgia, and Florida and met with the representatives and members of the local Turkish-American organizations in order to support their public education and advocacy efforts. One such event took place when the U.S. Department official Douglas Silliman appeared before the local organization members in Georgia, on September 8th and 9th, and spoke about the current status of U.S.-Turkey relations.

ATAA Annual Delegation Trip

Each year in late spring the Assembly organizes delegation trips to Turkey and to a friendly country. This year the participating delegates visited Istanbul, Ankara, Moscow, St. Petersburg, and Baku, where they met with the highest officials of the countries visited, attended special events organized specifically for their visit, and got a chance to explain ATAA's activities and mission. The leaders of the American Jewish Committee (AJC) of Florida were also a part of this year's trip.

ATAA Annual Convention

The theme of this year's convention is "Building Bridges to Strengthen Relations". Over fifty high-profile speakers, numerous representatives from Turkic, Turkish, American, and Student organizations, key government officials, and members and friends of the Turkish American communities, once again, will get together during this significant event and express their thoughts, con-

cerns, and aspirations on Turkish and Turkish American causes, and share their past, present, and future efforts regarding the issues at stake.

New Component Associations

We are honored to welcome two new component associations to the ATAA family. The Istanbul University Alumni Association of the U.S.A (IUMEZ-USA) (www.iumezusa.org) and the Middle East Technical University Alumni Association –USA both joined the Assembly, raising the total number of the associations under the Assembly's roof to sixty four. The Tristate Turkish American Association is also our new candidate.

New ATAA Members

Since the beginning of January 2006, forty nine new individuals made donations to the Assembly and became members. The total amount brought to the Assembly's budget by our new members is \$5,415. In addition, as a result of regular updates and reminders to our former members, who were active between years 1999 and 2004, seventy seven of them renewed their memberships, contributing a total of \$11,810 to the Assembly.

Central Office Progress and Functions

All of the computers and other equipment in the office were checked, repaired, and reinstalled for further use. For ensuring transparency and reliability of our records, and reaching consistency with the terms of our status as a 501(c)3 organization, new database systems, both for the financial and membership records, were initiated.

Several local groups continued taking advantage of the allocated space at the Turk Evi. The office personnel enabled the use of the conference rooms, as it was needed by ATA-DC for their Children's Folklore Group, Adult Language School, and by other local music groups.

Internships

This year, ATAA had five interns, tirelessly working at its headquarters. Mrs. Basak Akdeniz, Mr. Murat Onur, Ms. Burcu Tanriverdi, Ms. Si-haeng Lee, and Ms. Esra Alemdar helped the office staff in several daily operational tasks. Under the American Turkish Student Internship Program (ATSIP), two Turkish-American students were placed as interns at the Congress this year. Ms. Sevil Kaymakcalan interned at the congressional office of Joe Willson of South Carolina 2nd district, while Mr. Gunay Yilmaz was in Indiana's 5th district representative Dan Burton.

ATAA Annual Delegation Trip to Turkey



By Oya Bain Each year in late spring, Assembly of Turkish American Associations (ATAA) organizes delegation trips to Turkey and to a friendly country. ATAA members and officers from different parts of the US, Canada and Turkey join the delegation. All expenses are paid by the individuals themselves. These trips are unique in that the delegates meet with the highest officials in Turkey and in the country visited, attend special events organized for them, get a chance to network, exchange information and explain ATAA's activities and mission.

In the past years ATAA delegations visited Azerbaijan, Turkish Republic of Northern Cyprus, Greece, Israel, Bulgaria, and Germany and had a spectacular two week trip to East and Southeast Anatolia. The journey usually starts in Ankara or in Istanbul.

In June 2006, under the leadership of ATAA president Vural Cengiz, the itinerary included Istanbul, Ankara, Moscow, St. Petersburg and Baku. This year the leaders of the American Jewish Committee (AJC) of Florida were part of the ATAA delegation thanks to Vural Cengiz who had established excellent ties with the Jewish community in Florida over the years.

The first stop of the itinerary was in Istanbul on June 2, at Bahcesehir University, Besiktas Campus for a three day conference on "Global Leadership" and "US-Turkish Relations", featuring a wide range of excellent speakers.



The conference opened with a speech by the former Turkish President Suleyman Demirel, who gave a global view of the issues, stressing the global terrorism threats. He still has impressive mental acumen and excellent oratorical skills. Later Ishak Alathon and Can Kirac gave interesting insights to their long careers as industry leaders. Ambassador Mark Parris presented a realistic and concise speech on the current US-Turkish relations. He sounded guardedly optimistic. Ambassador David Mack of Middle East Institute, was impressive in his impartial and articulate view of affairs in the Middle East.

Dr. Soner Cagaptay, former congressman Bob Livingston, Ambassador Morton Abramowitz, Alan Makovsky were among the speakers. ATAA President Vural Cengiz spo-



ke on lobbying and grassroots activities of the Turkish community in the US. Stephen Beiner president of the AJC Florida Chapter (part of ATAA delegation) spoke on Turkish-Jewish relations. There were dinners and lunches on the top floor of the University with sweeping views of the Bosphorus. Mehmet Agar, leader of Dogru Yol party, was the keynote speaker at the final banquet. There were short meetings with journalists Mehmet Ali Birand, Sami Kohen, Defne Samyeli, with officials Namik Tan, spokesperson for the Turkish Foreign Affairs Ministry (now Ambassador to Israel) and Mehmet Ali Bayar of the Dogru Yol party. The conference closed with remarks by the Education Minister and State Minister, Huseyin Celik and Mehmet Ali Sahin respectively.

The conference which was also a course for Bahcesehir students, was very well organized and attended. ATAA thanks Professor Suheyl Batum, President of Bahcesehir University, to Burak Kuntay, the director of Government and Leadership School, and to all the Bahcesehir volunteers who were excellent hosts of this outstanding event

The delegation trip continued to Ankara on June 4-7, 2006. The first item on our agenda in Ankara-as alwayswas the wreath laying ceremony at Anıtkabir. This visit which we have done many times in the past, never fails to move us. There, in the serenity of the impressive mausoleum overlooking Ankara-and figuratively all of Turkey- one fully comprehends the momentous events leading to the rebirth of the Turkish nation and the greatness of its leader, Atatürk ATAA President Vural Cengiz and American Jewish Committee-Florida Chapter President Stephen Beiner lead the group in the wreath laying ceremony. Later, the group visited the new museum in the lower floors of the Anitkabir which has very realistic and impressive displays of scenes from Istiklal Savaşı (Turkish Independence Wars of 1920 -1923) with sound effects and authentic battlefield artifacts. A large map of Anatolia displaying the occupation zones by the English, Italian, French, Greek and Russian-Armenian forces after the World War 1 reminded the viewers of the the suffering of the Turks, life and death battles of Istiklal Sava**ş**ı and the caution must be shown to day in dealing with these nations.

Later that day the delegation was hosted by Professor Ziya Aktas, President of Cankaya University and profesor Emel Dogramaci, Dean of the Faculty of Arts and Sciences. Cankaya University is a new and vibrant institution built by the philanthropy of a well to do donor.

In the following days we met with Foreign Minister Abdullah Gul and Ambassador Selahattin Alpar, several opposition leaders and the chief of staff and some lea-






ders of the Turkish Armed Forces. President Sezer and Prime Minister Erdogan were not in Ankara during our visit. We had a guided tour of the impressive Museum of Anatolian Civilizations. Ambassador Ross Wilson, the US Ambassador to Ankara hosted a reception for the delegation.

During the meetings, President Cengiz outlined ATAA's activities and the scope of its mission. Delegation members expressed their views and concerns as seen from the other side of the Atlantic: Threat to Turkey's secularism, Turkish government taking a stronger stand regarding the ethnic pressures in the US and providing support to organizations like ATAA, the importance of a strong Turkish army and economy in Turkey's foreign policy. The extremism of the Armenian Diaspora in the US and their totally misguided approach oblivious to the realities in the Caucuses were also discussed. It was stressed that the opening of the border between Armenia and Turkey would be counterproductive in view of the shortsighted Armenian Diaspora policies in the US and Europe.

The trip to Russia (June 12-18) was very interesting and more touristic in nature. The Turkish Ambassador to Moscow, Kurtulus Taskent had a long meeting with the delegation. He described the developing Turkish Russian relationships, especially in the economic areas. In







fact, few days later President Sezer had a productive visit with President Putin.

In Moscow there were meetings with the leaders of the Turkish businessmen's groups. The message is that Russia is growing rapidly and there is tremendous potential for the Turkish businesses. Russia is sitting on huge oil and gold reserves and has other vast unexplored resources. Politically it is also charting its own course and seem annoyed by the interferences from the west.

In St. Petersburg, the northern city near Finland, the delegation enjoyed the "white nights", very long days with few hours of darkness. The Hermitage Museum

was spectacular, the city was majestic yet warm and friendly.

After few days back in Turkey, the ATAA delegation flew to Baku, Azerbaijan on June 23 at the invitation of of Azerbaijani Diaspora Minister Nazim Ibrahimov. Minister Ibrahimov and his entourage were the guests of ATAA earlier in May 2006 in Washington DC.

We were greeted with great hospitality and warmth. The group stayed in a boutique hotel in the heart of the historic district of Baku overlooking the Caspian Sea. There were many social events, including a colorful and rich Azeri wedding, visits to historic and archeological sites, to the Turkish and Azeri Şehitlik (cemeteries) and to Aliyev Memorial and meetings with key government officials.

ATAA delegation paid a courtesy visit to the Turkish Ambassador to Baku, Turan Morali. We reiterated our view that the opening of the Turkish Armenian border should be contingent on the resolution of the Armenian occupation of Nagorno-Karabakh region of Azerbaijan.

There was much discussion with Minister Ibrahimov and others about organizing the Azerbaijani Diaspora in the US into a ATAA like association, where they number close to 1 million. However major portion of the US Azeris are from Southern Azerbaijan (Northern Iran) and are not too involved with issues important both to Turkey and Azerbaijan.

Cultural issues and the feasibility of holding a large Turkish-Azeri festival were discussed with the Minister of Culture Abdulfez Garayev.

ATAA President Cengiz had a meeting with President Ilham Aliyev, which appeared in the newspapers the following day. The delegation's visits and meetings were also covered in the evening news on Azeri television.

ATAA group's visit to Azerbaijan coincided with the official opening of the Baku-Tbilisi-Ceyhan pipeline. The revenues from this pipeline which carries 1 million barrels a day from a large offshore field in Caspian Sea, to Ceyhan, will double Azerbaijan's current GDP in 2010.

ATAA President Vural Cengiz and the ATAA Delegation thank Minister Nazim Ibrahimov and his wonderful staff for hosting a very informative and pleasant stay for the ATAA group in Baku.
