The Assembly has grown into an organization that represents Turkish American organizations in the United States, Canada and Turkey.

The Assembly of Turkish American Associations is the preeminent umbrella organization of Turkish American associations throughout the United States, Canada and Turkey, dedicated to pursuing the interests of Turkish Americans and Friends of Turkey in Washington and beyond. Founded in 1979 in Washington, DC, ATAA has established itself as an influential player in strengthening the relationship between the United States and Turkey.

To fulfill its mission, objectives and strategic plans, ATAA follows an outline that includes a wide array of activities. These activities include educational seminars on grassroots advocacy and civic leadership; conferences on contemporary political, social and economic issues related to Turkey and Turkish American relations; cultural events to share Turkey's rich traditions, art and heritage; leadership seminars aimed at guiding component associations in compliant operation; as well as numerous charitable activities for Turkish and American causes.

As the principal umbrella organization for Turkish Americans, ATAA regularly publishes reference material on issues that affect the Turkish American community, including position papers, power point presentations, booklets and electronic communications. ATAA also has an extensive reference center, in which educators, the media and the general public may purchase materials by prominent authors on Turkey-related issues.

#### **TOMRIS AZERI**

Ms. Tomris Azeri serves as the President of the Azerbaijan Society of America (ASA). She has been the driving force in many of the organizations' initiatives, programs and special events which have fostered a greater understanding and appreciation of the people and country of Azerbaijan by the people and legislators of the United States. Ms. Azeri initiated successful ASA programs such as coordinating legislative informational luncheons for Congressional members and staff in Washington, DC; the raising of the Azerbaijani flag on Wall Street in New York in celebration of Azerbaijan's Independence Day; representing the Azerbaijani community to Mayor Bloomberg's Office of Immigrant Affairs in planning for the future of NYC; coordinating the sister city arrangements connecting Ganja, Azerbaijan with Newark, New Jersey; instituting and overseeing scholarship programs for Azerbaijani students studying in US; coordinating and presenting a variety of cultural activities for the Azerbaijani and American communities; involving ASA in support of the Turkish Day parade; and overseeing annual Azerbaijani celebrations in the U.S. She works closely with the Turkish-American community in all of these and other activities. She is a regular párticipant in a variety of Turkish - Azerbaijani initiatives, including most recently the Turkish-Azerbaijani Forum which took place in Baku, Azerbaijan in March, 2007. Ms. Azeri is a recipient of the Order of Glory medal, Azerbaijan's highest award, which was presented by Azerbaijani President Ilham Aliyev in March 2006.

Dr. Virginia Foxx was reelected to her second term to represent North Carolina's Fifth District in the United States House of Representatives in November 2006. She is the third woman in North Carolina history to serve in the U.S. House. Dr. Foxx serves on the House Committees on Agriculture, Government Reform, and Education and the Workforce. Prior to serving on Capitol Hill, Foxx spent ten years in the North Carolina Senate. Hill, Foxx spent fen years in the North Carolina Senate.
Dr. Foxx is a graduate of the University of North Carolina at Chapel Hill where she received her A.B. degree in English and M.A.C.T. in Sociology. She earned her Ed.D. in Curriculum and Teaching/Higher Education from UNC-Greensboro. Dr. Foxx began her career as a secretary and research assistant at UNC-Chapel Hill. She taught at Caldwell Community College, was a sociology instructor at Appalachian State University and held several administrative positions at ASU, including Assistant Dean of the General College. Dr. Foxx also Assistant Dean of the General College. Dr. Foxx also served as Deputy Secretary for Management in the N.C. Department of Administration for Governor Jim Martin. Prior to her election to the Senate in 1994, she served as President and later a consultant at Mayland Community College from 1987-1994. She served on the Executive Committee of North Carolina Citizens for Business and Industry and was elected to three four-year terms on the Watauga County Board of Education. She was confirmed by the United States Senate for a Presidential appointment to the National Advisory Council for Women's Educational Programs. She also served on the Z. Smith Reynolds Foundation Advisory Panel. Other current or former service on boards includes the Board of Directors of the John William Pope Center for Higher Education Policy, Board of Directors of the N.C. Center for Public Research, the UNC-Chapel Hill Board of Visitors, National Conference of State Legislatures' Plant Visitors, National Ćonference of State Legislatures' Blue Ribbon Advisory Panel on Child Care, Charter Member of the Mount Airy Museum of Regional History and the Foscoe-Grandfather Community Center Board. Dr. Foxx is married to Tom Foxx. Prior to her entering Congress, the couple owned a nursery business in Watauga County.

#### **DAVEED GARTENSTEIN-ROSS**

Daveed Gartenstein-Ross is the vice president of research at the Foundation for Defense of Democracies. He consults for a number of clients, both governmental and private, who need to be at the forefront of understanding terrorism and Islamic extremism. Gartenstein-Ross has conducted law enforcement training for the Department of Homeland Security and local agencies, and has served as a Subject Matter Expert for the U.S. Department of State's office of antiterrorism assistance. She was a national chairman of the Assembly's Curriculum Committee History and Social Science. She has represented Turkish American interests at high-level State Department meetings, addressed human relation commissions nationwide, worked on a one-to-one basis with innumerable congressional representatives and their staffs as well as delivered expert testimony before the Committee on Foreign Relation Relations. She was developing and implementing educational and public relations programs as deemed necessary. She has appeared on radio and television nationwide as an educator, advocate and facilitator for a better understanding of Turkey and her people.



#### **SUAT KINIKLIOGLU**

Suat Kiniklioglu entered Justice and Development Party (AK Party) from the German Marshall Fund of the United States. He is a member of the Turkish Parliament as well as the Spokesperson on the Foreign Affairs Committee, AK Party Deputy Chairman of External Affairs as well as Member of the NATO Parliamentary Assembly, Chairman of the Turkish-British Inter-Parliamentary Friendship Group, Member of the Executive Board of the Turkish-American Inter-Parliamentary Friendship Group; Secretary General of the Turkish-Dutch Inter-Parliamentary Friendship Group; and a Member of the Auditing Board of the Turkish-German Inter-Parliamentary Friendship Group. He has an impressive educational background with a PhD in Political Science from Bilkent University and Masters in International Relations as well as a Bachelors of Arts degree in Political Science from Carleton University in Canada and a Bachelor of Science in Electronics from the Turkish Air Force Academy in Istanbul. Mr Kiniklioglu speaks Turkish, English, German and Russian.

#### **ALI KOKNAR**

Washington, DC-based Ali M. Koknar is a private security consultant, specializing in counterterrorism and international organized crime. He studied law and business management in Turkey and in South Africa. Ali served in the artillery and ordnance corps of the Turkish Army and with the South African Police Force. As a counterterrorism researcher and analyst, Ali's writings are published in the US, UK, Turkey and Europe, and he lectured for NATO, Turkish National Police and the US Department of Defense. While his work takes him to locations such as Central America, Middle East and the Caucasus, he remains an associate of the Terrorism Research Center in Virginia, and an associate fellow of the Institute for the Analysis of Global Security in Maryland.

#### **METODIJA KOLOSKI**

Koloski co-founded and serves as the President of the United Macedonian Diaspora (UMD), the largest global NGO addressing the interests and needs of Macedonians and Macedonian communities throughout the world. Metodija is first generation Macedonian-American, born and raised in NJ. Metodija has an extensive background in Russian and Eastern European affairs, government relations, and fundraising. In his professional capacity, he is the Government Affairs Specialist at DLA Piper US LLP. Prior to DLA Piper, he worked in the Development Office of the Woodrow Wilson International Center of Scholars. Metodija has held international Center of Scholars. Metodija has been quoted by numerous international publications on Macedonian and Eastern European affairs, including Congressional Quarterly, the Globe and Mail, among others. He has been published in several Macedonian

publications, the Center on International Affairs, the Australian Age, and the Washington Times. Metodija holds a BA in Political Science and Legal Studies from Manhattanville College, where he conducted his thesis on the Rights of Macedonian Minorities in Albania, Bulgaria, Greece, and Serbia.

Upon returning to Baku he began to work as a police officer and simultaneously continued his education at Baku State University. After two years, he came to the US for further education. He graduated from North Carolina State University with a bachelor's in business management and master's in accounting. Upon graduation, he worked for the State of North Carolina as a state auditor until he was relocated to Washington, DC. Currently, he works for the federal government as a senior accountant. He is also a Certified Public Accountant. He serves as vice-president of the Azerbaijan Society of America and represents this organization in the DC area. He is treasurer/financial officer and also co-founder of the US Azeris Network (USAN). He is married with a 3.5 year old son Memmed.

#### **JEAN SCHMIDT**

A lifelong resident of Clermont County, Jean Schmidt is the first woman ever elected to represent Southern Ohio in Congress. Congresswoman Schmidt was elected to office to fill the remaining term of former Congressman Rob Portman. Ambassador Portman resigned from the Second Congressional District seat in 2005 after being confirmed as the United State Trade Representative. Congresswoman Schmidt was re-elected in November 2006 to serve a full term in Congress. Jean serves the Committee on Agriculture and the Committee on Transportation and Infrastructure. Throughout her career, Congresswoman Schmidt has held various public offices and continues to be actively involved in civic and community groups. She served for two terms in the Ohio House of Representatives where the Cincinnati Enquirer described her tenure by saying she "...proved effective in passing legislation to address her district's concerns." While serving in the Ohio General Assembly, Schmidt enacted legislation to create jobs, protect Ohio's children and ensure access to quality healthcare. Prior to Jean's election to Ohio's House of Representatives, she served 10 years as a Miami Township Trustee. She helped Miami Township to become a world-class community by initiating a variety of projects and improvements, including creating a 300 acre first class park system, securing funds for critical transportation improvements, and attracting more than 2,000 high paying jobs in the

Township. Congresswoman Schmidt holds a degree in Political Science from the University of Cincinnati and her interests include auto racing and long distance running. She has competed in more than 60 marathons and continues to compete across the country. She resides in Miami Township with her husband Peter.

#### H.E. NABI SENSOY

H.E. Nabi Sensoy became Ambassador of Turkey to the United States on Jan. 10, 2006. Ambassador Sensoy previously served as Deputy Undersecretary of General Political Affairs at the Ministry of Foreign Affairs (2002-05), Ambassador to Russia (1998-2002), Deputy Undersecretary of Political Affairs for the European Union (1997-98), Director-General of the Department of Policy Planning at the Foreign Affairs Ministry (1995-97), and Ambassador to Spain (1990-95). He was also Chief of Staff to the president (1988-90), Consul General in London (1985-88), advisor to the prime minister (1983-85), as well as Counselor at the Turkish embassy in Washington, D.C. (1980-83) and in Cuba (1979-80). Before that, he served as Head of Section at the Department of Bilateral Political Affairs for Western Europe (1977-79), First Secretary at the Turkish Embassy in Venezuela (1975-77), Vice Consul at the Turkish Consulate General in New York (1972-75), and Third Secretary and Second Secretary at the Department of Research in the Foreign Affairs Ministry (19070-72). Ambassador Sensoy is a graduate of the Faculty of Political Sciences at the University of Ankara.

#### **DAVID SALTZMAN**

David Saltzman is a principal member of Saltzman & Evinch, PC. He is now in his 15th year of representing clients involved in Turkish-American affairs. In his four terms [1987-1995] as the Congressman for the First District of New York, he distinguished himself as a leader on issues critical to Long Island and our nation. While in Congress, he served on both the House Armed Services and Merchant Marine and Fisheries Committees for eight years. Before being elected to Congress, Hochbrueckner served for ten years as a Member of the New York State Assembly. After graduation from high school, Hochbrueckner served in the United States Navy for three years where he was trained as an Aviation Electronics Technician, which became the basis for his 20+ year engineering career. After being honorably discharged in 1959, he attended the State University of New York at Stony Brook and Hofstra University and California State University at Northridge. After 2-1/2 years of college, Hochbrueckner pursued full time on-the-job engineering training. He worked his way from technician to senior engineer within 5 years. He also studied at Wesley Theological Seminary in Washington, D.C., where he now serves on the Board of Governors. Congressman Whitfield served in the Kentucky House of Representatives from 1974-75 while practicing law in Hopkinsville, where he operated a successful oil distributorship in the west Kentucky coal fields. In 1979, he became Counsel to the President of Seaboard System Railroad in Washington, D.C. Later, he was named Vice President of State Relations and then Vice President for Federal Railroad Affairs for CSX Corporation. Whitfield served as Legal Counsel to the Chairman of the Interstate Commerce Commission (ICC) from 1991 to 1993 where he worked to reduce regulation of the nation's barge, railroad and trucking industries. Congressman Whitfield serves on the House Committee on Energy and Commerce. Whitfield is the ranking member on the Commerce, Trade, and Consumer Protection (CTCP) Subcommittee. In addition to CTCP, Whitfield serves on the Subcommittee on Energy and Air Quality, which oversees national energy policy as well as utility issues and regulation of nuclear facilities, and the Subcommittee on Oversight and Investigations which has jurisdiction over a wide range of Departments, Agencies and issues. The Congressman is married to Connie Harriman, who served as Assistant Secretary of the Interior and Director of the U.S. Export-Import Bank and, currently, as Senior Vice-President of the Humane Society.
